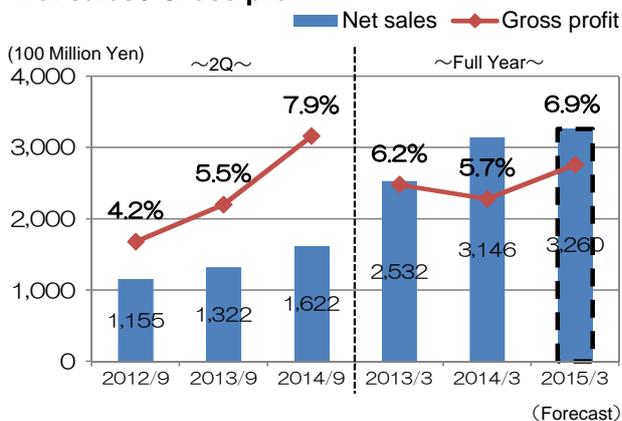

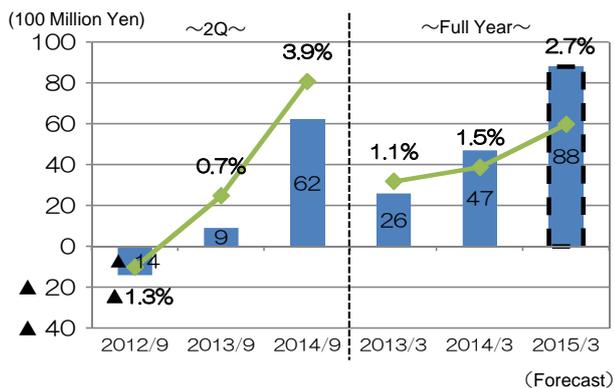

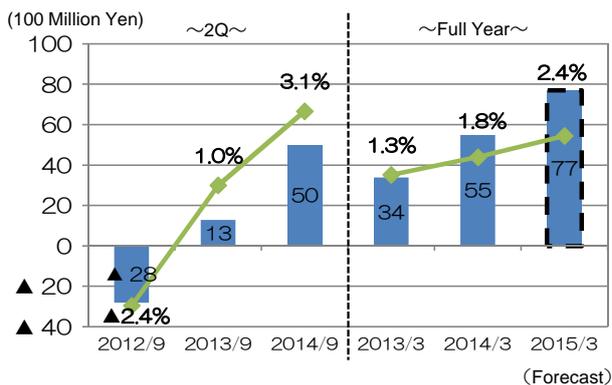
### Net sales / Gross profit

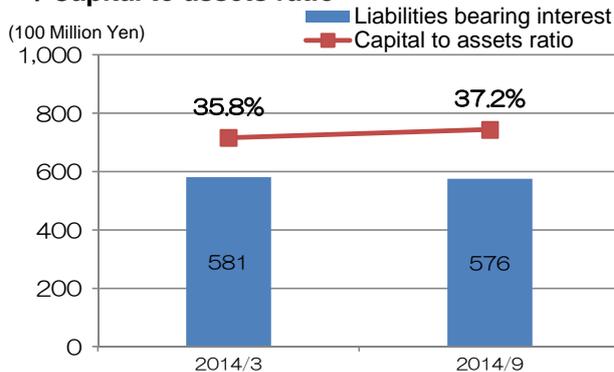

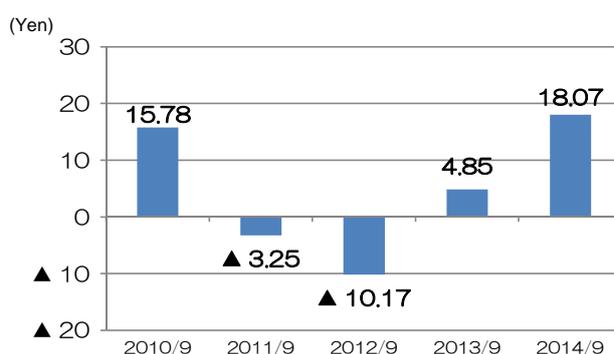
