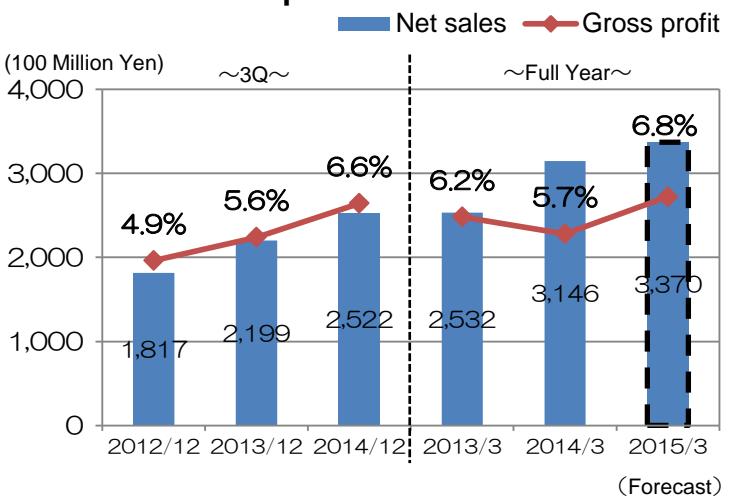

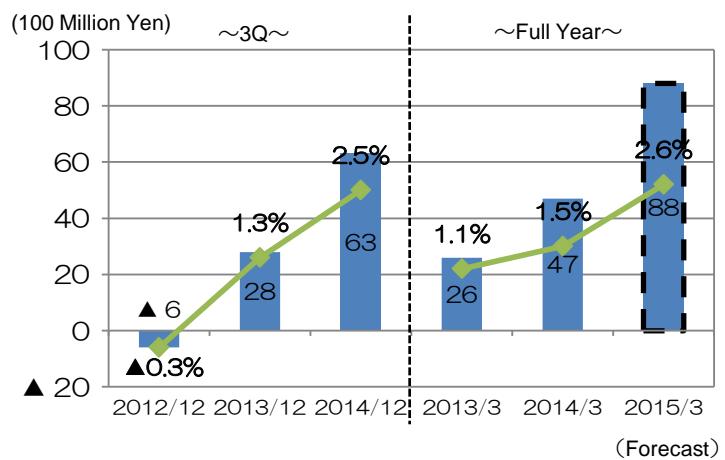

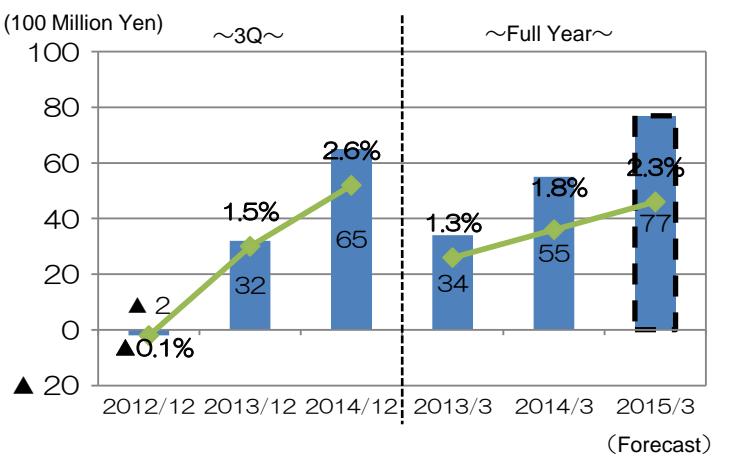
Net sales / Gross profit

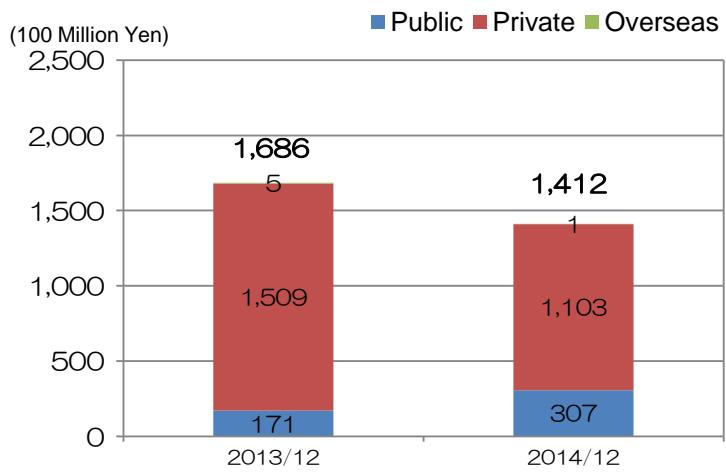
Works carried forward (This FY 3Q)

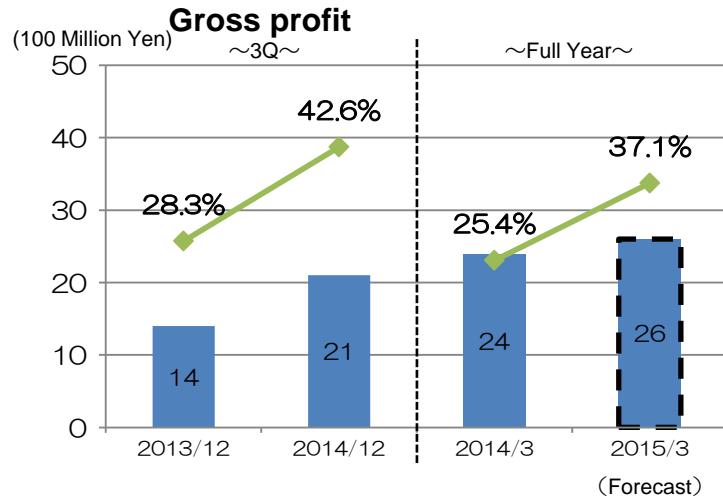

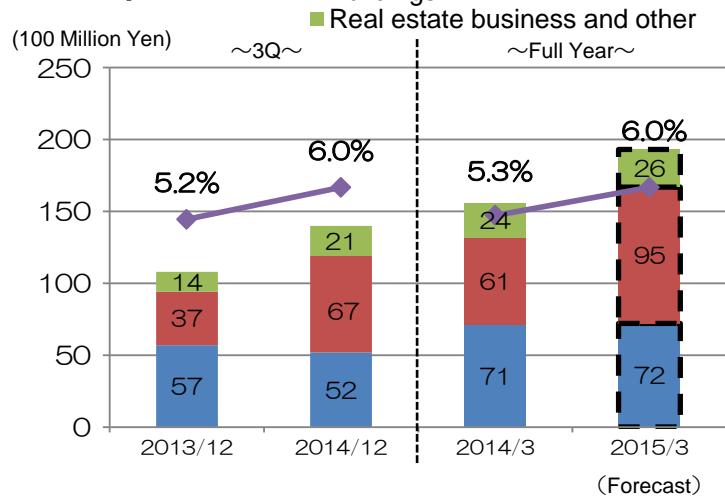
Buildings Gross profit
